## Competition Rules

No refunds after entries received.

Dancers will pick up numbers at registration table upon verification of SOBHD card.

Dancing rules and scruinteering will be as recommended by SOBHD. Judge's decision is final. No access to judges' result sheets.

In the event of a protest being lodged, a \$25.00 fee must accompany the written complaint and must be postmarked & forwarded within a period of 7 days. This fee will be returned if the protest is upheld.

Dancer age will be as of the date of competition. Classes will be decided based on the number of entries. First to enter last to dance.

Dancers must report promptly to dance area when called or risk disqualification in that event.

Competitors must be in full dress, including slippers, to receive awards. Medals will be awarded on the basis of the number of competitors. Trophies will be awarded to the Beginner & up classes. Cash awards are to be given to the oldest premier group. Dancers must present a valid SOBHD card to receive awards. Classes will be decided based on the number of entries.

PCHDA will not be responsible for any lost articles, injuries or accidents to contestants or spectators.

No coaching by teachers or parents while dancers are on stage.
